1. A grant request will be looked upon more favourably if the local Real Estate board and/or its members are involved with the charity.
2. The application deadline is June 30th and decisions are made in the fall of each year.
3. Your application must have a letter from the local Real Estate board President stating that they endorse your charitable work in their community.
4. The Board of Governors of the REALTORS Care Foundation will consider a request for emergency disaster relief funding at the time of the application.

Grant requests for the following are not accepted:

- Budget Deficits
- Fundraising Events
- Endowments
- Theatre or performing arts groups
- Private foundations
- Service or fraternal clubs
- Religious institutions
- Agencies/Organizations which raise funds for distribution to other community organizations
- Third Party organization fundraising on behalf of a shelter related charity
